Terms and Conditions:-

1. Tender is invited for providing a Maruti SWIFT Dezire (A/c) / Honda Amaze (A/c) vehicle for a period of twelve months.
2. Rates are to be quoted for providing the vehicle up to 2000 Kms per month. Rates shall be inclusive of GST.
3. No additional claim will be entertained for a distance up to 2000 Kms.
4. The vehicle should be in good running condition and should be 2018 model or of later model with proper registration, insurance, Pollution Certificate, taxi permit, qualified and licensed drivers with sufficient fuel. In case of any accident, all repairs shall be done by the contractor without any liability to Kerala Social Security Mission or its employees. In case the car is withdrawn for maintenance repairs another suitable/similar car shall be provided without any loss of time.

5. The contract period will be for one year from the date of providing of Vehicle. If the Executive Director, Kerala Social Security Mission so desires the contract may be extended further. During this extended period of contract, rates and other conditions will not be changed under any circumstances.

6. The vehicle should be provided on all days in a month and at any time as may be required, failing which another car should be provided at the risk and cost of the contractor. The vehicle along with driver should be available for the use of Kerala Social Security Mission - State Initiative on Disabilities on 365 days, 24 x 7 basis.

7. The vehicle shall be parked and stationed at the risk of the contractor at Kerala Social Security Mission Office and the Executive Director, Kerala Social Security Mission shall not be liable for any damage loss sustained.

8. No separate bata for driver will be given for outstation duties.

9. In case of accident, all repairs shall be done by contractor without any liability to Kerala Social Security Mission or its employees, or the vehicle using officers, with no delay.
